Responsibility for data processing

Purposes and legal basis of data processing

The data gathered from the above-mentioned individuals as part of the funding programme will exclusively be used for the purposes of coordination, execution and administration of the funding programme (including verification, evaluation and handling of applications), as well as to meet the statutory obligations of pbm Academy. In doing so, pbm Academy relies on the necessity of processing to safeguard the legitimate interests of pbm Academy with respect to the effective and legally compliant implementation of the funding programme, including, where applicable, the establishment and implementation of a contract with the applicant within the scope of the funding programme, as well as to satisfy the legal obligations in this regard.

Necessity of providing personal data

The provision of personal data in this application form is a prerequisite for participation in the funding programme as pbm Academy can only ensure coordination, implementation and administering of the funding programme, as well as full appraisal and evaluation of the application, when this data is available. There is no obligation to participate in the funding programme.

Transfer of data

pbm Academy's service provider (Burson-Marsteller GmbH, Lyonel-Feininger-Strasse 28, 80807 Munich, Germany) also gains access to the personal data for the above-mentioned purposes. The service provider shall solely process the personal data on the behalf of pbm Academy insofar as this is necessary for inspecting, evaluating and processing the applications. Data is not transferred to other recipients unless pbm Academy is obliged to do so on the basis of statutory obligations or official directives.

Retention period for data

The personal data shall only be stored by pbm Academy for as long as is necessary for realising and fully implementing the funding programme, unless a longer retention period is required due to statutory retention periods, or to safeguard our legitimate interests (assertion, exercising or defence of legal claims).

Data subject rights

According to statutory provisions, those affected by the data processing by pbm Academy (data subjects) have the right:

- To request information on the personal data processed by pbm Academy as well as a copy of this data (right of access);
- To request the rectification of incorrect data and, while observing the purposes of processing, to request that incomplete data be completed (right to rectification);
- To request the deletion of his/her data where there are legitimate reasons to do so (right to erasure);
- To request that the processing of his/her personal data is restricted provided that the statutory conditions apply (right to restriction of processing);
- To obtain his/her personal data in a structured, commonly used and machine-readable form if the statutory conditions apply, and to have this data transferred by pbm Academy to another controller where this is technically feasible (right to data portability); and
- Not to be subjected to a decision based solely on an automated processing, insofar as the statutory requirements for this do not apply. pbm Academy does not currently perform any automated decision-making.

Furthermore, those affected by pbm Academy's data processing (data subjects) have the right to object to the processing of his/her data, which is being performed for the purposes of safeguarding the legitimate interests of pbm Academy, on the basis of reasons arising from his/her personal circumstances in accordance with the statutory provisions (right to object). If personal data is processed by pbm Academy for the purposes of engaging in direct advertising, the data subjects have the right to object to this processing at any time without the need to provide any particular reason.
